



ESR Completes Construction of Langfang Chunhui Business Park

New ESR facility sits in the heart of Langfang Economic and Technological Development Zone (LETDZ), supported by an excellent transportation network between Beijing and Tianjin

HONG KONG, 8 December 2022 – ESR Group Limited ("ESR" or the "Company", together with its subsidiaries, the "Group"; SEHK Stock Code: 1821), the largest real asset manager in the Asia-Pacific region powered by the New Economy, has completed another state-of-the-art manufacturing facility, the ESR Langfang Chunhui Business Park in Northern China. With a planned GFA of more than 48,600 sq.m., this newest facility was completed in November 2022.

ESR Langfang Chunhui Business Park is located in the heart of Langfang Economic and Technological Development Zone (LETDZ), which is strategically situated in the midway between Beijing and Tianjin, and supported by an excellent transportation network and support facilities such as water supply, electricity supply, gas supply and heating. At present, the LETDZ has attracted more than 6,000 registered enterprises from 23 countries and regions around the world, including electronic information, high-end equipment manufacturing, new materials and new energy, life sciences,

modern logistics, e-commerce and other modern industrial systems¹. ESR Langfang Chunhui Business Park is a two-storey structure adhering to high industry standards for warehousing and is built on a concrete-filled steel tubular system that resists wind and seismic forces. The pillarless warehouse allows for flexible space usage to meet the needs of advanced intelligent manufacturing and supply chain operations. Notably, the roof is also equipped with pre-cooling solar panels, a reflection of the new facility's seamless integration of low-carbon innovations.

Jeffrey Shen and Stuart Gibson, ESR Co-founders and Co-CEOs, said, "The completion of the Langfang Chunhui Business Park demonstrates the continuous progress in our New Economy development in China. The ESR differentiated facility has been attracting a broad spectrum of investors and customers, serving as a catalyst for the Group's development. Going forward, we are excited about the next chapter of growth as APAC's largest real asset manager and in spearheading New Economy manufacturing in China."

ESR has a total AUM of US\$32 billion and approximately 13.9 million sqm of GFA in China as of 30 June 2022.
